### **SERVIZI ITALIA: One new contract awarded in Lazio at the Tor Vergata Policlinico, Rome.**

#### **The contract is worth around € 9.4 million over a 9-year period.**

Servizi Italia S.p.A., a company listed on the STAR division of the Electronic Stock Market (MTA) of Borsa Italiana, in its role as group leader in a Temporary Association of Companies, was awarded a new contract in Lazio, at the Tor Vergata Policlinico in Rome, to provide both laundry and linen services and general supply of operating theatre sterile clothing and surgical instruments.

For Servizi Italia the contract is worth around €9.4 million for the entire 9-year duration, with the possibility to revise prices in accordance with ISTAT indexes. The Tor Vergata Policlinico is a new client for Servizi Italia.

Specifically, Servizi Italia will provide laundry and hire services for hospital linen, uniforms and sterile surgical sets for the operating theatre, as well as hiring sterile surgical instrument kits, both through external management operations (including the renovation of buildings and systems) and through the management of the current substerilisation areas within the hospital.

Servizi Italia thus strengthens its presence in Central Italy, by developing high-added-value sterilisation services in the Lazio region, and further to winning a six-year contract, at the beginning of the year, for the running of the sterilisation plant within the San Camillo – Forlanini hospital in Rome, which will allow it to meet the need for sterilisation services on the part of other hospital facilities in the regional area.

“This new contract – commented Servizi Italia’s CEO Luciano Facchini – represents the achievement of an important commercial objective in the Lazio Region, especially given the length of the contract, which will allow us to develop high-added-value sterilisation services. This demonstrates that our clients see Servizi Italia as a professional, reliable partner to whom “core” services can be entrusted, which is a source of great satisfaction for our company”.
